### Accommodations Dana Cup

Hotel accommodation in a nice hotel in the center of Frederikshavn in rooms for 4 people to a room. Rooms usually have 2 twin/single beds and one bunk bed. Daily breakfast is included. Front desk, bar, lounge, restaurant and indoor pool. All 4 bedded rooms are equipped with a private bathroom with bathtub and/or shower, equipped with a hairdryer, wireless internet access, TV, desk and a chair. Single, double and triple rooms are available as well. Supplement per week \$1,160.00 for a single room per stay, \$355.00 per person per stay for sharing a double and \$ 45.00 per person per stay for sharing a triple. You can order meal cards through the Dana Cup, cafeteria type meals – to be served at the Dana Cup center – \$115.00 for a meal package, dinner, and lunch each day from Monday dinner until Saturday lunch.

### Ground transportation Dana Cup

During the Dana Cup the tournament organizer will offer airport/harbor transfers as well as public transportation passes to be used throughout the week to travel between your accommodation and Hjørring.

### Accommodations Norway Cup

This 4-star hotel is situated in a quiet neighborhood adjacent to the grounds of the Royal Palace. The rooms offer a private bathroom, free Wi-Fi, TV, and mini fridges. Daily breakfast is included. Hotel has front desk, lounge, and restaurant. Participant prices are based on 3 or 4 people to a room. Following supplements for other room types:
