#### Travel dates:

July 26 - August 5, 2024

#### Itinerary:

- July 26 Departure from DFW airport on the following flight on British Airways BA 192.  
**Departure Dallas FW 07:15PM – Arrival London Heathrow July 27th – 10:20AM.**
- July 27 Arrival London Heathrow airport.  
**Transfer to your accommodation in the Manchester area.**
- July 28 Sightseeing Manchester. One of the most popular sights is the Old Trafford stadium, home of Manchester United (included) and optional tour English National Football (Soccer) Museum.  
**Evening game vs. a local team.**
- July 29 Morning training session per team with a youth coach from a pro club in the Manchester area. More sightseeing Manchester, or sightseeing in Liverpool. See popular sights like Royal Albert Dock, Liverpool Cathedral and/or do an optional stadium and museum tour of Anfield, home of Liverpool FC.
- July 30 Optional day trip to Chester, a magical city over 2000 years old; it is the most complete walled city in Britain. Walk the walls – 2 miles of entirely walkable walls, studded with historic towers and a bird's eye view of the city center. Look over the other side of the wall for a view of the Welsh mountains in the distance. Afterwards you can head for the Roman Amphitheater and The Chester Cathedral (14th century church).  
**Evening game vs. a local team.**
- July 31 **Transfer to your accommodation in London.** En-route stop at St. George's Park (English FA national soccer center) for a training session per team and tour of the facilities.
- August 1 Training session per team with a youth coach from a London area pro club. Sightseeing London. Options include The Tower of London, The Houses of Parliament, Buckingham Palace and/or The London Eye, with its spectacular views over London.
- August 2 Optional visit Hampton Court Palace and Windsor Castle. For almost 200 years, Hampton Court Palace was at the center of court life, politics and national history. Windsor Castle is an official residence of The Queen and the largest occupied castle in the world.  
**Afternoon or evening game vs. a local team.**
- August 3 Optional morning training or re-gen session with your own coaching staff. More sightseeing London, including a tour of Wembley, Emirates or Stamford Bridge Stadium (included).
- August 4 Enjoy the day sightseeing in London. Visit to the Chelsea Village MegaShop, Trafalgar Square and Covent Garden shopping precinct.  
**Morning/afternoon game vs. a local team.**
- August 5 Afternoon/evening visit to an EPL pro match (Community Shield might be an option depending on exact date it is scheduled in 2024).  
Breakfast and morning transfer to London Heathrow airport.  
**Departure London Heathrow 12:50PM – Arrival Dallas FW 04:50PM.**

#### \*Note on itinerary:

The above itinerary is a provisional/suggested itinerary and can/will change depending on the final game schedule, training session dates and times for your team(s) and any pro game visit(s) incorporated for your group. Sightseeing admission fees are not included in the prices but can be added and pre-booked based on your group's specific wishes. Consult us for more information.



#### Tour price per person per team:

The per person tour price will be determined by averaging out per team based on total number of travelers amongst all 4 teams (example: 120 total travelers/4 teams = average of 30 travelers per team). The tour price will be determined and confirmed around January 1, 2024, after receipt of all applications from all teams and the number of total travelers is known.

#### Price inclusions:

- Round trip airfare, including airport taxes and fuel surcharges. Prices are always subject to availability of flights and fares at time of booking.
- Accommodation and meals as specified in this proposal – see below.
- Ground transportation – see below.
- Costs for arranging the sport program – see below.
- Services of a local tour assistant – see below.
- Administration of registrations, payments from all travelers and communication of tour arrangements to all travelers to be done by Premier International Tours.

#### Extra costs (options not included in prices):

- Sightseeing entrance fees – approx. \$75 extra per person for students/16 and under (\$100 for adults and over 16 years) – for required entry fees to recommended sights in itinerary – London Eye, Tower of London and Windsor Castle or Hampton Court Palace and the National Football Museum in Manchester.
- Tickets to a pro soccer game, like the Community Shield or other EPL match – approx. \$100 or more per person (depends on match).

- Extra activities for the teams/players like yoga sessions, lectures/classroom from pro club coaches/staff (match analysis, sports psychology, sports nutrition). Costs for this TBC, but we would estimate approx. \$500.00 total per session.
- Travel Insurance policy – average cost approx. \$108 per person – see below.
- Double (two people per room) or single rooms in the hotels – Supplement for a double room is \$135 per person per stay. Supplement for a single room is \$495 per person – see below under “Accommodation and meals included”.
- Lunch daily – we recommend budgeting approx. \$20 per day.
- Gratuities for representatives and bus drivers – we recommend budgeting \$20-\$30 per person for this.

#### **Sport program included:**

- We will arrange 4 friendly games per team. Games will be arranged against English teams of comparable level to the traveling teams. We have access to all levels of clubs in England, including youth pro academy teams.
- We will arrange a training session per team with a youth coach from a London area pro club like Tottenham, Fulham, Crystal Palace, etc.
- We will arrange a training session with a youth coach from a Manchester area pro club like Man City, Liverpool, Everton, etc.
- We will arrange a training session per team with an English FA coach at St. George's Park, headquarters of the English FA, along with a tour of the facilities.
- We will arrange two pro team stadium tours – one in Manchester (Old Trafford, Etihad Stadium or Anfield in Liverpool) and one in London (Wembley, Emirates or Stamford Bridge).

#### **Accommodation and meals included:**

##### **Manchester area (July 27-31):**

##### **3-or-4-star hotel accommodation in the Manchester area.**

- Daily breakfast and dinner included.
- Hotel accommodation Northwest England located between Manchester and Liverpool.
- Accommodation in triple rooms (3 people – 3 twin beds). Rooms all have private bathrooms, phone, satellite TV and free Wi-Fi.
- Double and single rooms available as well. Double rooms available at a supplement of \$ 15.00 per person per night and single rooms available at a supplement of \$ 55.00 per person per night.
- The hotel has a restaurant/lounge, sometimes an indoor pool, sauna/solarium, and fitness center.
- Please be aware that rooms in Europe are smaller than the ones we are used to in the USA.

#### London (July 31-August 5):

##### 4-star hotel accommodation in London.

- Daily breakfast and dinner included.
- Hotel accommodation on the outskirts of London about 15 miles from the city center.
- Accommodation in triple rooms (3 people – 1 double bed + 1 sofa bed). Rooms all have private bathrooms, phone, satellite TV and free Wi-Fi.
- Double and single rooms available as well. Double rooms available at a supplement of \$ 15.00 per person per night and single rooms available at a supplement of \$ 55.00 per person per night.
- The hotel offers a restaurant, lounge/bar, outdoor patio/garden, fitness center and free Wi-Fi.

##### Ground transportation included:

During your entire stay your team will have a private bus available exclusively for your team/group – 10 hours a day.

##### Local guide services included:

Each team will have a local tour manager assigned to be exclusively with that team full time each day during the stay at each destination to provide any assistance when necessary and help plan or amend the daily schedule as needed.

##### Travel insurance option:

Your participants have the option to purchase accident, illness, and trip cancellation/interruption insurance, including a Cancel for Any Reason Coverage (CFAR) – more information about this insurance is included on your team website. Costs of the policy are determined by the policy you select and the age of the traveler and tour cost.

**Within 1 week of departure date** the cancellation fee will be **100%**.

Anything to the contrary notwithstanding, you agree to hold the Released Parties harmless for your failure to obtain insurance coverage and for any cost or claims, which could have been covered by health insurance if it had been obtained.
